Under the instructions from authorities, the company has already reversed under protest CENVAT credit of ₹ 3.09 Crores in t 2008-09. Pending disposal of the case a sum of ₹ 2.07 Crores reversed under protest is shown "Claims against the excise authorities" under the head "loans and advances". The matter came hearing several times during the financial year and the matter was adjourned to 16.04.2020. Ba legal advice, the company expects favorable outcome and no cash outflow is anticipated as the m one of interpretation of law

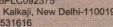
